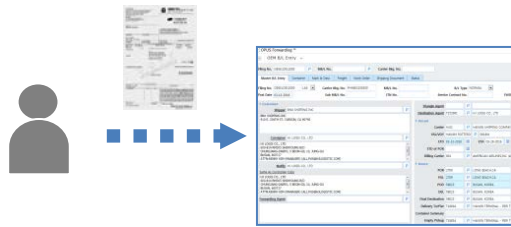

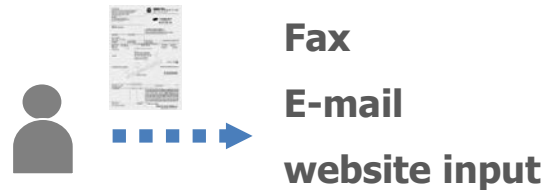

Current Shipping Instruction Process

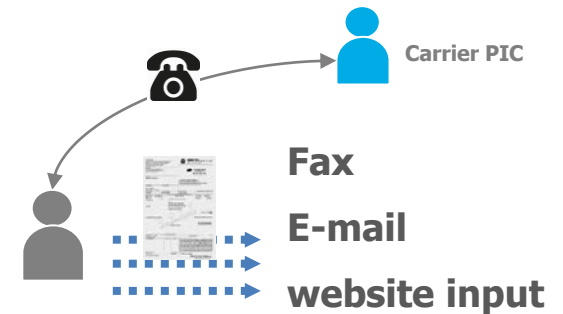
1 B/L Data Input to System



2 Sending to Carrier manually



3 Several conversations & Multiple correction



Inconvenient Point

- Double input the B/L data and documentation fee → Waste of Time & Cost
- Inaccuracy caused by human error
- Documentation delay due to multiple correction

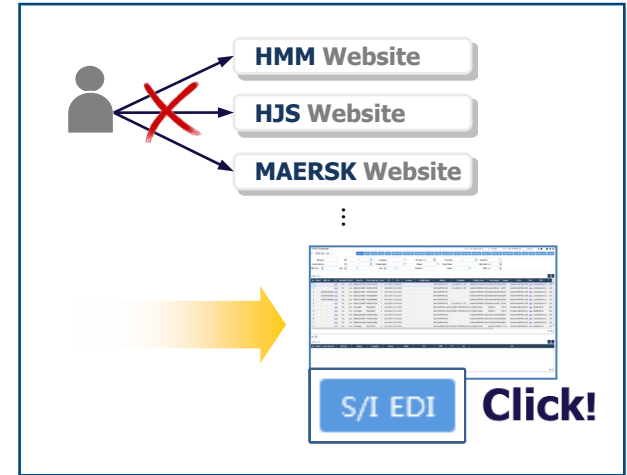

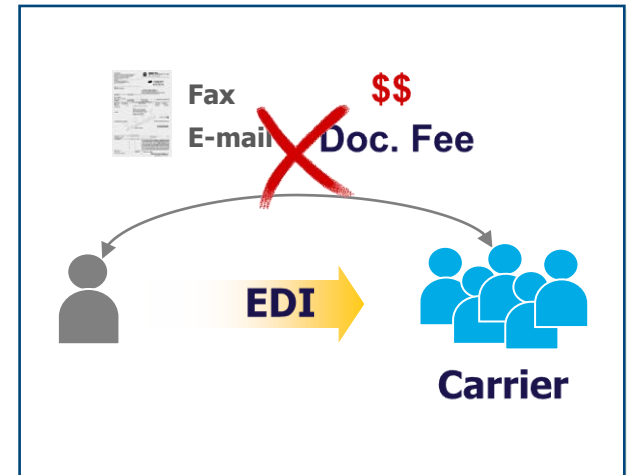
Improvement 1. No need of Double Input

- One Click and Sending Shipping Instruction using B/L data which is already input in OPUS Forwarding.
- Customer doesn't need to input shipment documents in the carrier's website any more.



Improvement 2. Waiver of Documentation Fee

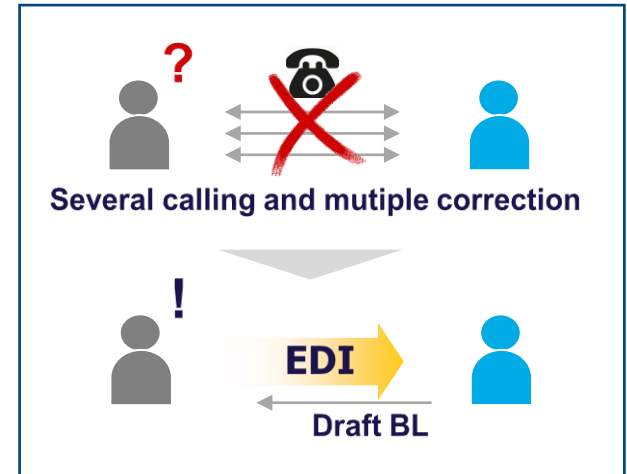
- Some carriers are charging documentation fee for shipment documents via Fax or Email.
- Documentation fee can be waived after transmitting shipment documents via SmartLink EDI.



02 Why SmartLink SI Service ?

Improvement 3. Speediness and Correctness

- Fast submission shipment documents to carrier before documentation cut off time.
- No need of several calling and multiple correction.
- Transmit shipment documents automatically by EDI and receive accurate response from carriers.



Improvement 4. Prepare for VGM regulations

- Shipper or Freight Forwarder should send verified cargo and container weight information to carriers to comply with Verified Gross Mass regulations of SOLAS.
- SmartLink can send verified cargo and container weight information including shipment documents EDI.
